- 3. All maintenance carried out at Lot 2, Gus Mauch Way, Warwick Airport, must be carried out in accordance with the provisions of Section 3 Paragraph 3.2.2 of the Flight Maintenance Australia Pty Ltd Maintenance Procedures Manual. Proposed changes to these paragraphs must be accepted by CASA in writing before being implemented.
- 4. Component maintenance activities approved under this certificate are limited to those components that are fitted to, or eligible to be fitted to aircraft maintained under this certificate.
